1.0 Executive Summary

SLR was commissioned by the IWMA on the 05/10/21 to carry out a study to analyse publicly available Environmental Protection Agency (EPA) data records to enable the time period for Waste and relevant IPC/IE (see section 3.0) facility licence applications and licence revisions to be determined.

Analysis of EPA determinations on By-Product notifications that were submitted to the EPA was also carried out by the SLR team.

During this study the time period is defined as the period from the initial application date to the EPA, up until a final decision is reached on the application. In order to carry out these analyses, SLR collated the relevant data from the 'Search for a Licence/Permit' section of the EPA website.

Excel driven numerical analyses were carried out to interrogate the data. The key findings from the analyses are summarised below with a more detailed overview of the results detailed in Table 1.

- The average time-period for a new licence application (Waste & relevant IPC/IE¹) was 2.2 years across the time period and 1.9 years since 2017.
- The average time period for a licence revision application (Waste & relevant IPC/IE) was 1.5 years across the time period and 2 years since 2017.
- Out of the total 2040 By-Product notifications submitted to date (over a 10-year period), 83% (1701) remain undecided.

¹ A number of Facilities licenced under IPC/IE comprise waste facilities or manage waste as part of their process, so they are deemed to be relevant to the study. This includes the cement kilns that burn Solid Recovered Fuel (waste).



2.0 Introduction and Background to the Study

SLR was commissioned by the Irish Waste Management Association (IWMA) on the 05/10/2021 to carry out a study to analyse publicly available Environmental Protection Agency (herein referred to as EPA) records. Specifically, the project focuses on the licensing process within the Waste Sector, including applications and licences applied for/granted to operate a waste facility under both Waste, Integrated Pollution Control (IPC) and Industrial Emissions (IE) Categories as well as notifications for by-product applications. The licence applications deemed to be of relevance and therefore included in the research are detailed in the Methodology section below.

The purpose of this study is to quantify the time-periods taken for the different licence applications for waste activities across the historical data. The application timescale refers to the time period from the initial application to the final decision date by the EPA, which marks the end of the application time period. It is understood that there is a Statutory requirement for a final decision to be reached for IPC/IE licence applications/revisions within the 12-month period following the initial application; however, there is no statutory required response time for Waste licence applications/revisions. Analysis of these time periods allows the performance of the licence application service to be assessed and year-on-year application completion times to be compared.

3.0 Methodology

In order to carry out the above-described analyses, SLR firstly identified the relevant data from the Environmental Protection Agency 'Search for a Licence/Permit' website section. The applications deemed to be relevant and included in the analyses are detailed in Table 2 below. The relevant data was then captured and transformed into an analysable format in an Excel document. Cement facilities were deemed to be relevant to the study with regard to waste-to-energy activities associated with cement facilities.

Once the data was captured, SLR interrogated the dataset via excel-driven numerical analyses to determine any trends within the dataset and quantify the overall performance of the licence application service provision over time. The collated data was analysed as follows:

- 1. Licence Application (IPC/IE and Waste separately)
- 2. Licence Revision (IPC/IE and Waste separately)
- 3. Licence Application & Licence Revision (Waste & IPC/IE separately)
- 4. Licence Application (IPC/IE and Waste combined)
- 5. Licence Revision (IPC/IE and Waste combined)
- 6. Licence Application and Licence Revision (IPC/IE and Waste combined)



Analysis of specific Licence Application types individually allows for a greater visibility of trends in application completion times, with grouped analyses providing a high-level overview of overall application completion times. Where an application is yet to reach 'Final Decision' SLR have indicatively included a proxy date to provide a best-case scenario minimum application completion time, all of these applications were analysed based on the same proxy date 05/10/2021. Both datasets used in these analyses are included as **Error! Reference source not found.** a nd **Error! Reference source not found.** respectively.

All of the publicly available By-product notifications were collated into an excel workbook where numerical analyses were carried out in order to determine the number of applications with determinations and those without. A copy of this dataset is included as Appendix 3.

Waste licence applications and revisions are identified with the prefix 'W', i.e., W0001-01, and IPC/IE licence applications and revisions are identified with the prefix 'P', i.e., P0001-01. It is known that waste licences may be transferred to become IPC/IE licences; however, for ease of analysis and understanding, this report maintains the separation using the original licence application.

4.0 Results

4.1 Waste Licence Applications & Revisions

4.1.1 Waste Licence Applications




Figure 1: New Waste Licence Application timeseries

The key points shown by Table 3 and Figure 1 below for Waste Licence Applications are a considerable variability in application times across the time series, ranging from a maximum of 4.2 years in 2009 to a minimum of 0.7 years in 2013 which overall equates to an average figure of 2.3 years across the data from application date to the date of the Final Decision. Average application completion times overall have been increasing since 2013 from 0.7 to 2 years in 2018.

4.1.2 Waste Licence Revisions

The Waste Licence Revision Application times detailed below in Table 4 and Figure 2 show a significant variability across the time series, ranging from application time periods of half (0.5) a year in 2006 to a maximum of 4.2 years in 2010. Overall, the average time for a Waste Licence revision to be completed is 1.4 years across the time series. The average application time has been significantly greater than the overall average since 2017.

4.1.3 Waste Licence Applications & Revision Applications




Figure 3: Waste Licence and Licence Revision Applications timeseries

Looking at both Waste licence and revision applications in Table 5 and Figure 3 below, the data shows a wide range of application response times from 0.8 years in 2013 to a maximum of 4.2 years in 2010; though there is no apparent correlation between the number of applications and the response time. The average application completion time across the period is 1.9 years.

4.2 IPC/IE Licence Applications & Revisions

4.2.1 IPC/IE Licence Applications

Detailed by




Figure 4: IPC/IE Licence Application timeseries for relevant facilities

Table 6 and Figure 4 below are the IPC/IE^2 application times for a new licence, with an average completion time of 1.6 years across the time series. From 2018 onwards the average time period is shown to be above the overall average, with a slight increase in completion time from 2018 to 2019.

4.2.2 IPC/IE Licence Revisions

Below are the completion times for IPC/IE licence revision applications outlined by Table 7, there is high variability in the completion times, ranging from a minimum of 0.3 years in 1997 to a maximum of 5.8 years in 2015. There does not appear to be any correlation between the number of applications in a given year and the respective completion time for an application. The average time for an application to reach final decision from application date across the time series is 1.8 years, completion times are shown to be above average in the latter 2 years.




Figure 5: IPC/IE Licence Revision Application timeseries for relevant facilities

4.3 IPC/IE Licence Applications & Licence Revisions




Figure 6: IPC/IE Licence Application & Licence Review timeseries for relevant facilities

Tabulated and graphed in Table 8 and Figure 6 are the combined completion times for both IPC/IE licence applications and licence revisions for relevant facilities. The data shows a wide range of completion times, ranging from 0.3 years in 1997 to 2.5 years in 2012. The latter years of 2018 and 2019 both have an average



completion time of 2 years, which is greater than the average completion time of 1.7 years for the whole time series.

4.4 IPC/IE and Waste Licence Applications




Figure 7: IPC/IE & Waste New Licence Applications timeseries for relevant facilities

Detailed by Table 9 and Figure 7 below are the combined completion times for licence applications for both relevant IPC/IE and Waste Licences, a significant variability is shown across the time series ranging from 0.8 years in 1995 to a maximum of 4.2 years in 2009. The average application completion time across the time series is 2.2 years, an increase in average application time can be seen in the recent years from 2017 to 2019.

4.5 IPC/IE and Waste Licence Revisions




Figure 8: IPC/IE & Waste Licence Revisions timeseries for relevant facilities

Shown by Table 10 and Figure 8 below are the application completion times for both relevant IPC/IE and Waste licence revisions, the data generally shows an upward trend in response times across the time period with a significant increase from 0.3 years in 1997 to 2 years in 2019. The average completion time for a licence revision across the time period is 1.5 years, thus the latter 5 years are shown to have considerably higher licence revision completion times than average.

4.6 IPC/IE and Waste Licence Applications & Revisions

Table 11 and Error! Reference source not found. both present the yearly averages for IPC/IE and Waste licence applications and licence revisions between the years 1995 and 2019. Overall, the average time taken was 1.9 years (23 months). The variation across the period can be seen in Error! Reference source not found. where a peak of 2.6 years in 1997 is evident alongside a peak to 3.4 years in 2010. To contrast, 1995 had an average timescale of less than a year (10 months). Error! Reference source not found. shows a weak positive correlation between the application response time and the number of applications in a given year.




Figure 9: IPC/IE & Waste Licences applications and Licence Revision completion times for relevant facilities

Table 12 below presents the breakdown of the average application time across the last 4 years of data. Application times have increased by C. a 1/4 of a year (3 months) across the 4 years to an average across the most recent 4-year period of 1.9 years.

4.7 By-products

4.7.1 Classification

As defined by Article 27 of the European Communities (Waste Directive) Regulations 2011 (S.I. No. 26 of 2011), a <u>by-product</u> is a substance or object, resulting from a production process, the primary aim of which is not the production of that item. For context, <u>waste</u> is defined as any substance or object which the holder discards or intends to or is required to discard and <u>production residue</u> is defined by a material that is not deliberately produced in a production process but may or may not be waste. Thus, a by-product is not waste, and enables support of the circular economy and Ireland's waste management policy. A case-by-case approach is adopted in determining whether a production residue is a by-product or waste. The steps to declaring by-product status are as follows (to be considered by the material producer/economic operator):

- 1. Has the substance or object been discarded, or is it required to be discarded, or intended to be discarded? If the answer is 'yes' to any of these, then the material is **waste** and <u>not</u> a by-product.
- 2. Was this substance or object <u>intentionally and deliberately</u> produced for a specific use? If the answer is 'yes', then the substance or object is a **product** and <u>not</u> a by-product.
- 3. Is the substance or object produced as a secondary consequence of the production process i.e., the production process did not directly seek to produce the substance or object. If the answer is 'yes', then the material is a **production residue** and may be a by-product or a waste.

Only a production residue can be considered by the EPA for further assessment as a potential by-product. To be classified as a by-product the <u>four conditions must be met</u>, these are outlined in Article 27 and are as follows:

- 1. The further use of the substance or object is certain
- 2. The substance or object can be used directly without any further processing other than normal industrial practice
- 3. The substance of object is produced as an integral part of a production process
- 4. The further use if lawful in that the substance or object fulfils all relevant product, environmental and health protection requirements for the specific use and will not lead to overall adverse environmental or human health impacts

4.7.2 By-product Notifications sent to the EPA

Once the material producer (or economic operator) has carried out the required assessment and decided that a substance or object is a by-product, the EPA must be informed. Once a notification is made, the EPA will endeavour to provide a determination in all cases which either:

- Determines to agree with the decision as notified by the economic operator that the material is a byproduct; or
- **Determines** that the material is a waste

A total of 2040 by-product notifications have been submitted nationally since 2011, excluding the applications which have since been withdrawn, all with the aim of achieving by-product classification. Of the 2040 notifications submitted, 83% (1701) remain undetermined to date, accounting for the removal of two notifications due to lack of status. Out of the 339 applications with a finalised determination, 202 (60%) were successfully classified as by-products whilst 137 (40%) were determined as waste.

Conclusion 5.0

The key findings of the study are:

- The average time-period for a new licence application (Waste & relevant IPC/IE³) was 2.2 years across the time period and 1.9 years since 2017
- The average time period for a licence revision application (Waste & relevant IPC/IE³) was 1.5 years across the time period and 2 years since 2017
- Out of the total 2040 By-Product notifications submitted to date at the time of the study, 83% (1701) remain undecided.
