Executive Summary

SLR was commissioned by the IWMA in March 2023 to carry out a study to analyse publicly available records to assess the timeframes for waste facility planning applications. In this report, we analysed a total of 270 such applications and decisions that were made via local authorities and a further 19 applications that were made directly to An Bord Pleanála via the Strategic Infrastructure Development (SID) process.

During this study the time period is defined as the period from the initial application date up until a final decision is reached on the application including any appeals.

For the SID cases, we include the pre-application consultation process in the timeframe as an application cannot be made until An Bord Pleanála terminates that process.

Excel driven numerical analyses were carried out to interrogate the data. The key findings from the analyses are summarised below with more detailed provided in Table 1-1-1.

- The data shows that the average time taken for all waste sector applications to local authorities in our dataset was 172 days, which is just under 6 months. The trendline shows that the timelines for making decisions has decreased over time.
 - It took on average 200 days (6.6 months) to reach a decision during the 1990 to 2000 period.
 - It took on average 173 days (5.7 months) to reach a decision during the 2001 to 2011 period.
 - It took on average 158 days (5.2 months) to reach a decision during the 2011 to 2022 period.
- The average length of time taken by An Bord Pleanála to decide appeals was 203 days (6.7 months). ABP has a target timeline of 18 weeks (126 days) to reach such decisions, so the results show that this target date has not been achieved on average for waste sector appeals. The data shows that 25 appeals were decided within the 18 week target, whereas 45 took longer than that.
- The data shows that the average time taken for all applications (including appealed decisions) was 225 days, which is 7.4 months. The trendline shows that the timelines for making decisions has decreased over time, as the series is dominated by the decisions that were not appealed.
- The analysis by county suggests that Kilkenny had the quickest decision-making process and was found to take on average 115 days (3.8 months) to reach a decision. Galway had the slowest decision-making process at an average of 390 days (12.8 months).
- The average time taken for the fourteen decided SID cases in our dataset was 844 days (2.31 years) from start to finish, including the pre-application consultation process. The slowest SID decision in our dataset relates to Indaver's 2012 application for the development of a Waste to Energy facility at Ringaskiddy in County Cork, which took 2,077 days (5.7 years). The fastest took 9.1 months.
- The average SID case in the waste sector has taken 3.75 times as long as the average standard planning application in the sector (844 days versus 225 days).

1.0 Introduction and Background to the Study

SLR was commissioned by the Irish Waste Management Association (IWMA) in March 2023 to carry out a study to analyse publicly available Planning Application Data provided by the relevant planning authorities. Specifically, the project focuses on the planning process within the Waste Sector, including applications to the local authorities, appeals to An Bord Pleanála and the Strategic Infrastructure process with An Bord Pleanála.

The purpose of this study is to quantify the time-periods taken for the different planning applications for waste activities across the recent and historical data. The application timescale refers to the time period from the initial application to the final decision date by the local authority and in cases of an appeal or in the Strategic Infrastructure Development (SID) process, by An Bord Pleanála.

2.0 Methodology

In 2022, SLR prepared a report for the IWMA on '*Waste Treatment Capacity in Ireland*' and this report is now publicly available on the IWMA website.¹ This was considered to be a good starting point as an inventory of waste management facilities in Ireland. SLR gathered planning application data on the facilities included in that inventory by interrogating local authority websites, An Bord Pleanála website and the EPA website.² This data gathering was supplemented by information provided to SLR by IWMA members during the course of the project.

Not all of the facilities in Waste Treatment Capacity Report are included in the analysis presented in this report, as some are quite old and not well recorded in the publicly available planning files. Also, many facilities have had multiple planning applications for various developments, changes of use and/or intensification of the activities. We tried to capture the most important planning decisions that allowed these premises to operate as waste management facilities and to further develop as such. We included more than one planning decision for many facilities.

In addition to the initial inventory, other waste management facilities were added in response to suggestions by IWMA members as well as reliance upon SLR's in-depth knowledge of the history of waste management in Ireland. In addition to historical facilities, these additions included facilities that received planning permission but were not yet operational and some recent ones that were still awaiting a planning decision, particularly in the Strategic Infrastructure Development process. Where an application is yet to reach 'Final Decision' the length of time taken should be considered as the minimum time for that decision.

Once the data was captured, SLR interrogated the dataset via excel-driven numerical analyses to determine any trends within the dataset and to quantify the overall performance of the planning system over time. The collated data was analysed as follows:

1. A timeline for applications prior to any appeals to An Bord Pleanála.
2. A timeline for applications that were appealed to An Bord Pleanála.
3. The overall time taken for An Bord Pleanála appeal and application process.
4. Strategic Infrastructure Development applications, including the pre-application consultation stage.

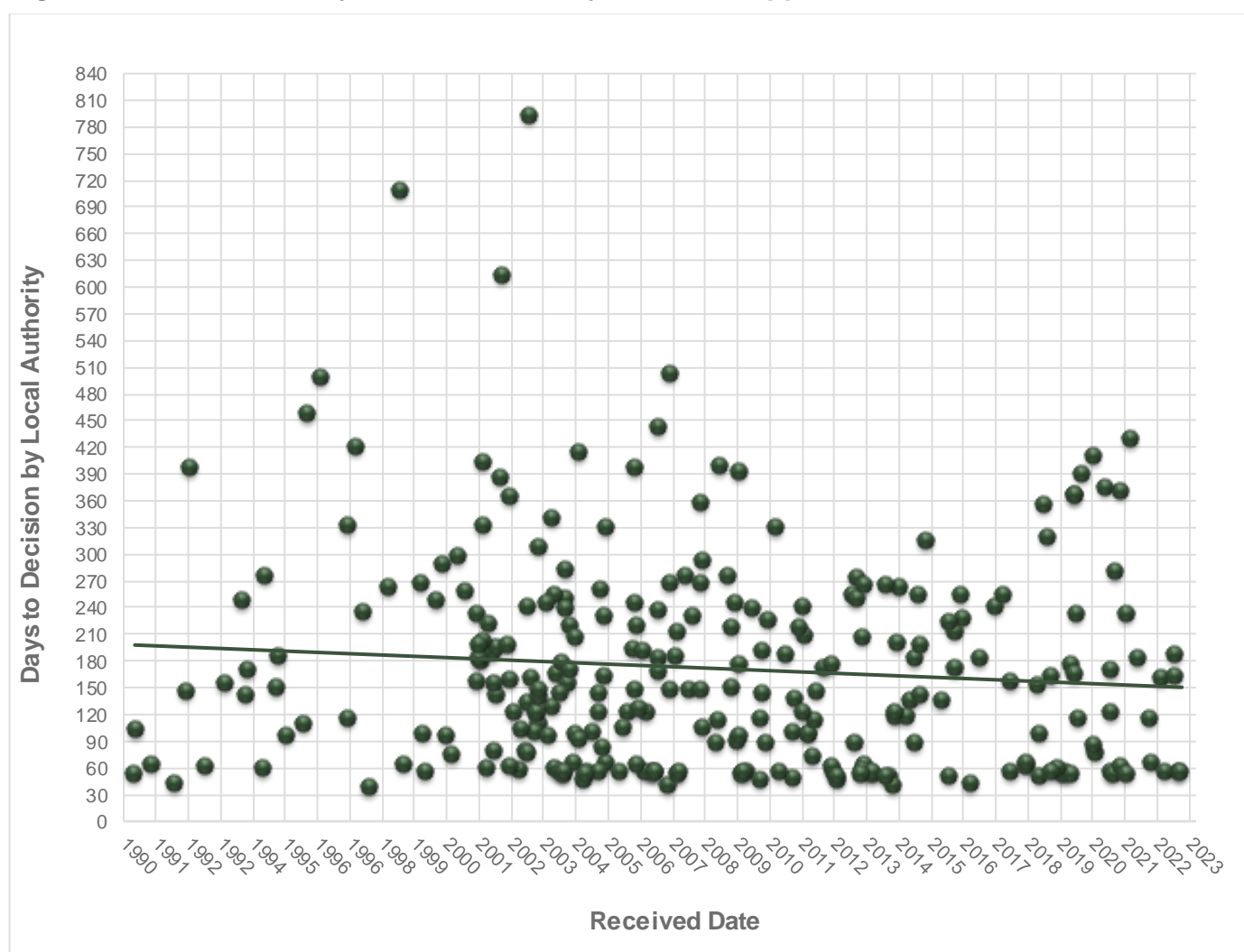
3.0 Results

3.1 Waste Sector Planning Applications to Local Authorities

The graphs in this section show the time taken for Planning Authorities to reach decisions on waste sector planning applications during the period 1990 to 2022. We analysed a total of 270 such applications and decisions.

Figure 3-1 shows the length of time for local authorities to make decisions on the 270 waste sector planning applications that are in our dataset. The datapoints are plotted on the X-axis based on the date the application was lodged and the Y-axis shows the time taken for the local authority to make a decision. The Y-axis gridlines are 30 days, so roughly 1 month each. A linear trendline has been plotted using an Excel program feature.

Figure 3-1 Local Authority Decision Times by Individual Application



The data shows that the average time taken for all applications was 172 days, which is just under 6 months. The trendline shows that the timelines for making decisions has decreased over time.

The three fastest decisions were taken in 37, 38 and 39 days. The slowest was 791 days (2 years and 2 months) and this related to a proposed landfill on the Kildare / Meath border, which proved to be a complicated situation that involved the two local authorities. In the end, one authority granted and the other refused. The development was then refused on appeal to Bord Pleanála.



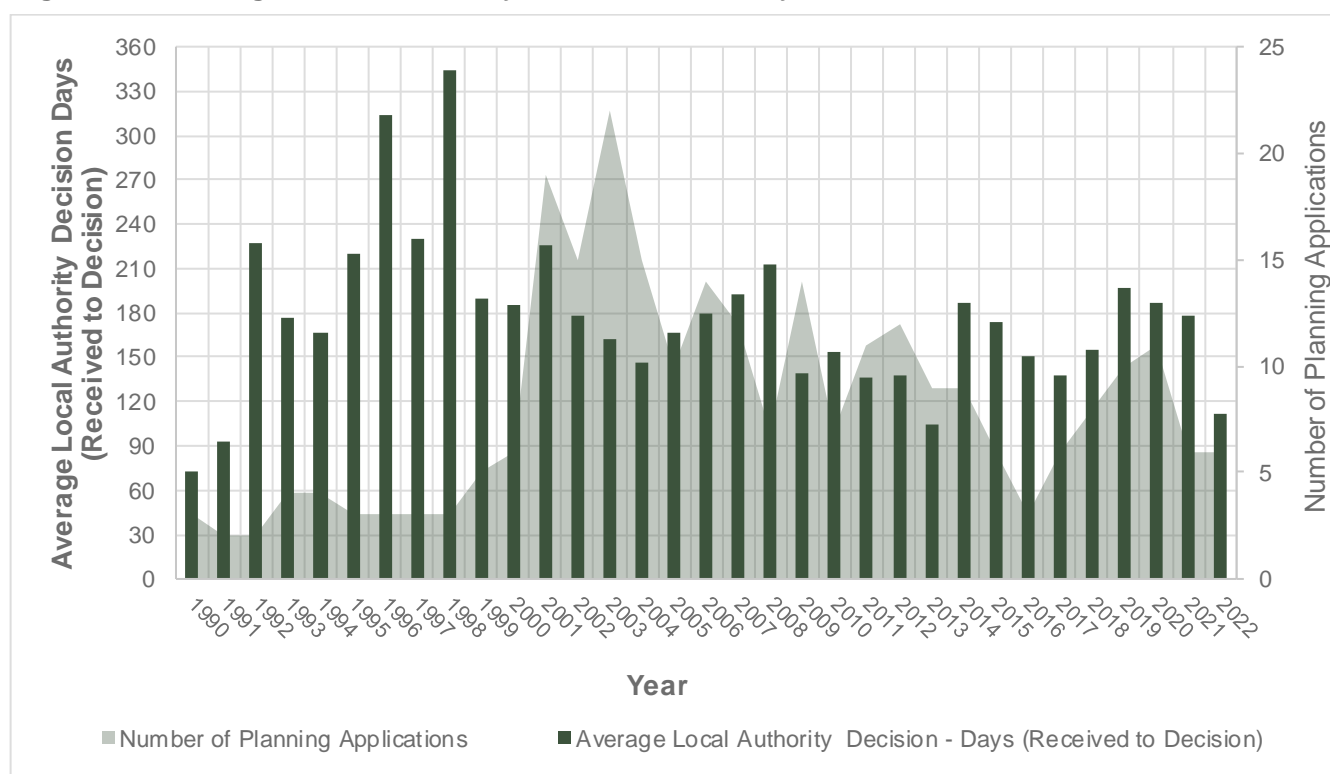
The second longest time taken by a local authority was for Ballynagran Landfill in Wicklow at 708 days. A further 20 developments took more than a year to get approval from the local authorities.

The data also shows that there was an increase in the intensity of planning applications in the waste sector from c.2001, which reflects the strong growth in the economy and construction at that time prior to the economic crash in 2007/2008.

It also reflects the transition from the over-reliance on landfill pre-2000 to the increased sorting and recycling of many waste streams from c.2000 onwards. This required the development of new and expanded waste transfer stations, materials recovery facilities and biological treatment plants.

Figure 3-2 presents the dataset in a different format, showing the average time for decisions on applications lodged with local authorities for each year from 1990 to 2022 as a bar chart. The Y axis on the right hand side of the graph shows the number of applications in our dataset for each year and this is represented as an area chart behind the bar chart.

Figure 3-2 Average Local Authority Decision Times by Year



The number of Planning Applications in our dataset from 1990 to 2000 was just 38, whereas we found 146 applications for the 2001 to 2011 period and 86 applications for the most recent decade from 2012 to 2022.

The data shows that:

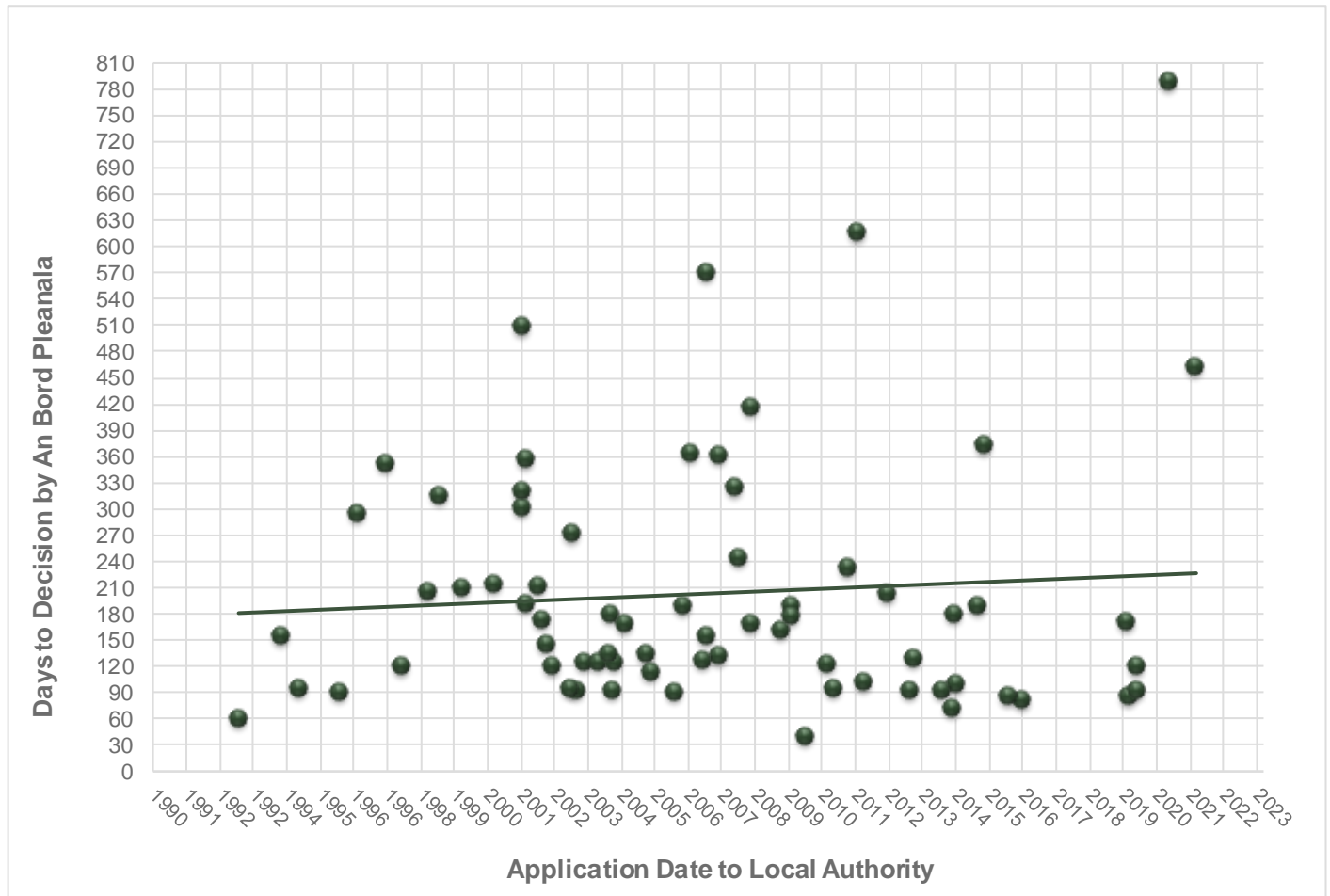
- It took on average 200 days (6.6 months) to reach a decision during the 1990 to 2000 period.
- It took on average 173 days (5.7 months) to reach a decision during the 2001 to 2011 period.
- It took on average 158 days (5.2 months) to reach a decision during the 2011 to 2022 period.

So the data shows that timelines for local authorities to make decisions on planning applications in the waste sector has gradually improved over time, which is consistent with the trendline plotted on Figure 1-3.



In Figure 3-3 below, we consider a subset of our dataset relating to those decisions that were appealed to An Bord Pleanala. A linear trendline has been plotted using an Excel program feature.

Figure 3-3 An Bord Pleanala Decisions on Applications that were Appealed.



A total of 70 decisions out of the 270 in our dataset were appealed to An Bord Pleanala (ABP). The linear trendline shows that timelines have been getting longer over time.

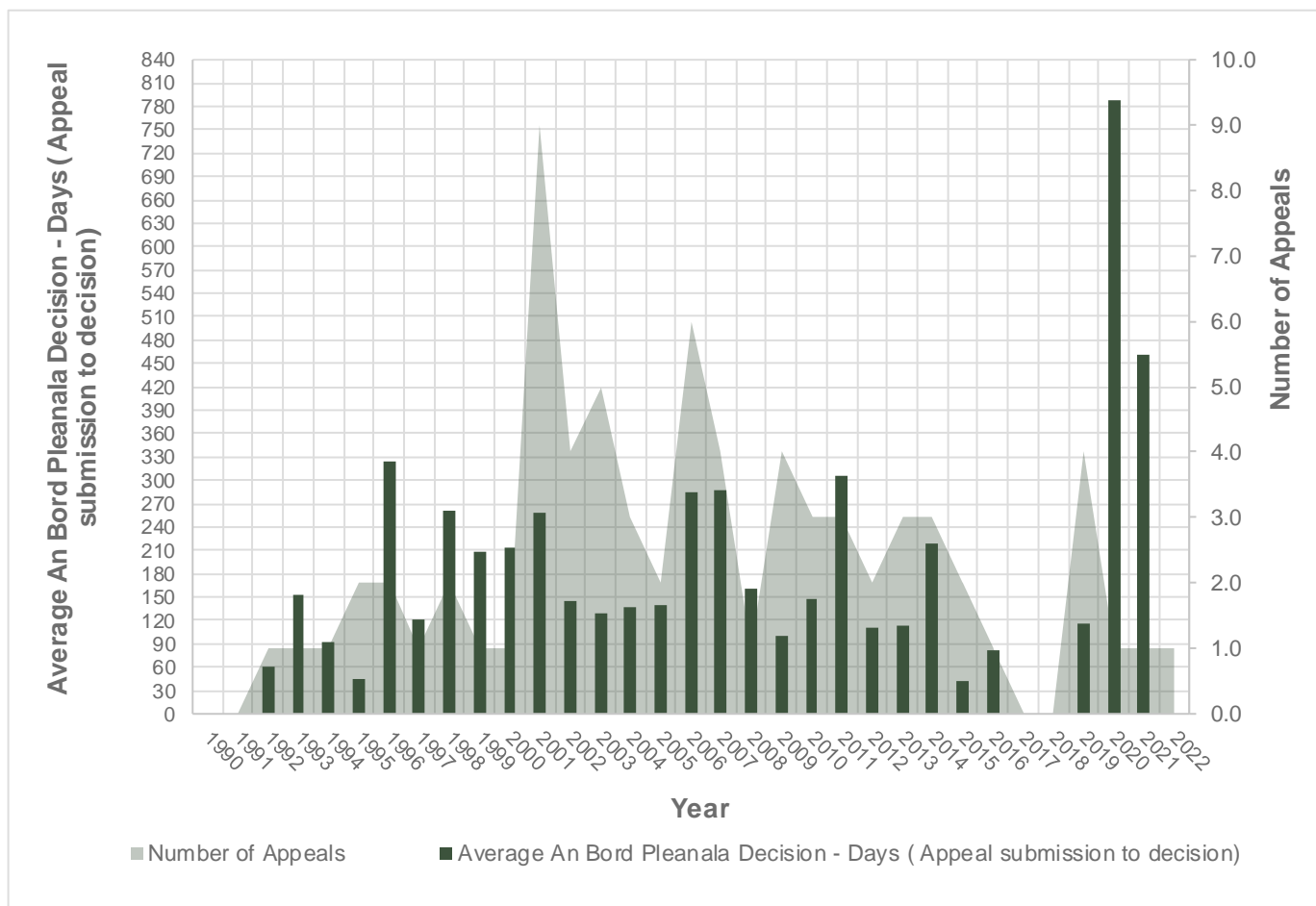
The average length of time taken by An Bord Pleanala to decide these cases was 203 days (6.7 months). ABP has a target timeline of 18 weeks (126 days) to reach such decisions, so the results show that this target date has not been achieved on average for waste sector appeals. The data shows that 25 appeals were decided within the 18 week target, whereas 45 took longer than that.

The longest appeal in our dataset is 787 days, relating to alterations to a composting facility near Littleton in Tipperary. That appeal remains undecided at time of writing, so the figure of 787 days (2 years and almost 2 months) is a minimum figure that is still increasing.

Figure 3-4 below presents the dataset in a different format, showing the average time for decisions by ABP on appeals for each year from 1990 to 2022 as a bar chart. The Y axis on the right hand side of the graph shows the number of applications in our dataset for each year and this is represented as an area chart behind the bar chart.



Figure 3-4 An Bord Pleanála Decisions by Year on Applications that were Appealed.

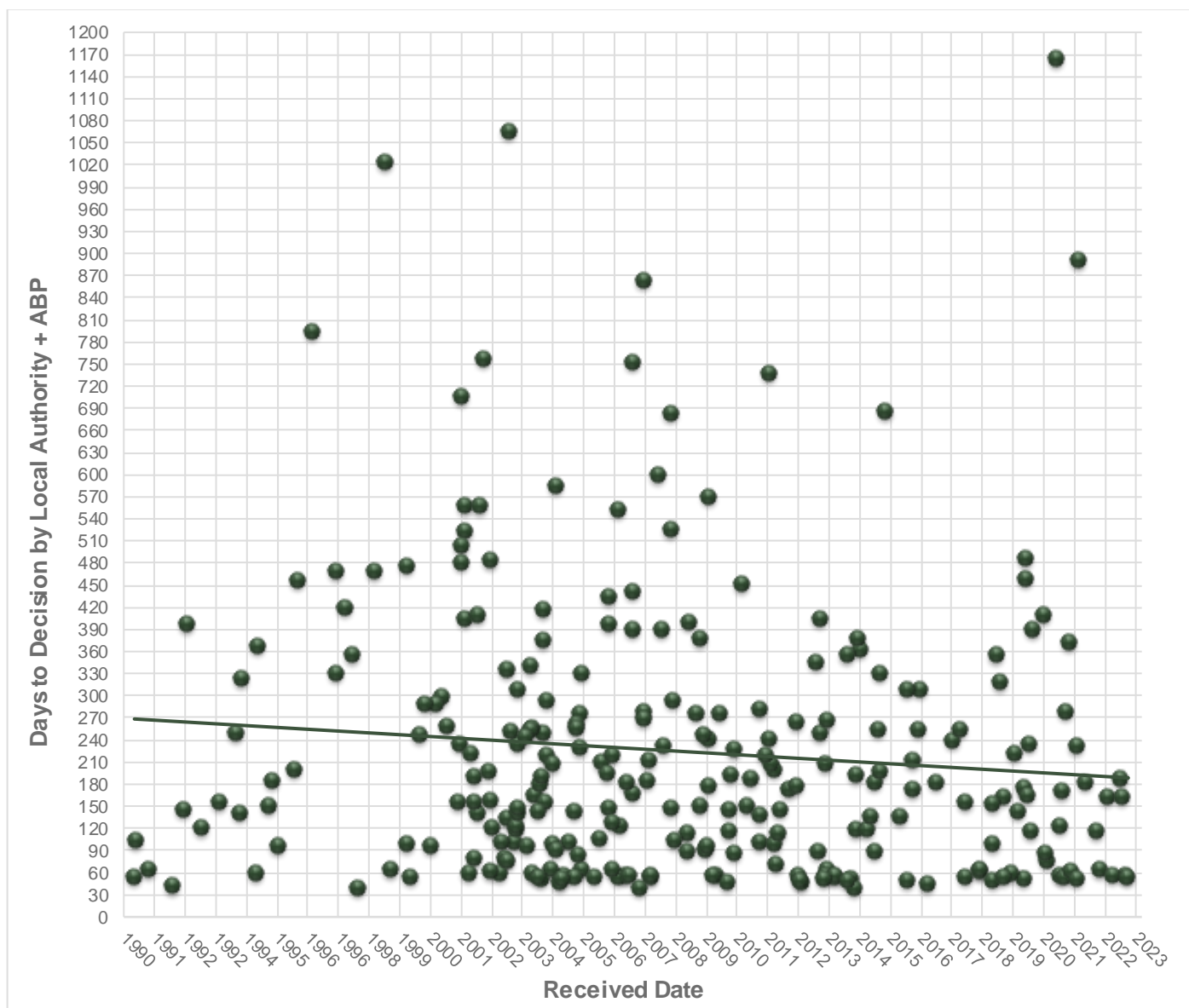


As the dataset is limited to 70 decisions over 32 years, it should not be over-analysed. However, it is clear that some recent appeals are taking a very long time compared to the average timeframe. The appeals in the 1990s appear to have the shortest timeframes. This observation is consistent with the linear trendline plotted on Figure 3-3.

In Figure 3-5 below, we combine the local authority data with the data from An Bord Pleanála to show the total time taken for applications in the waste sector over the 1990 to 2022 period. A linear trendline has been plotted using an Excel program feature.



Figure 3-5 Average Total days taken to receive a decision, including appeal.



The data shows that the average time taken for all applications was 225 days, which is 7.4 months. The trendline shows that the timelines for making decisions has decreased over time, as the series is dominated by the decisions that were not appealed.³ It is therefore more consistent with the local authority trend than with the ABP trend.

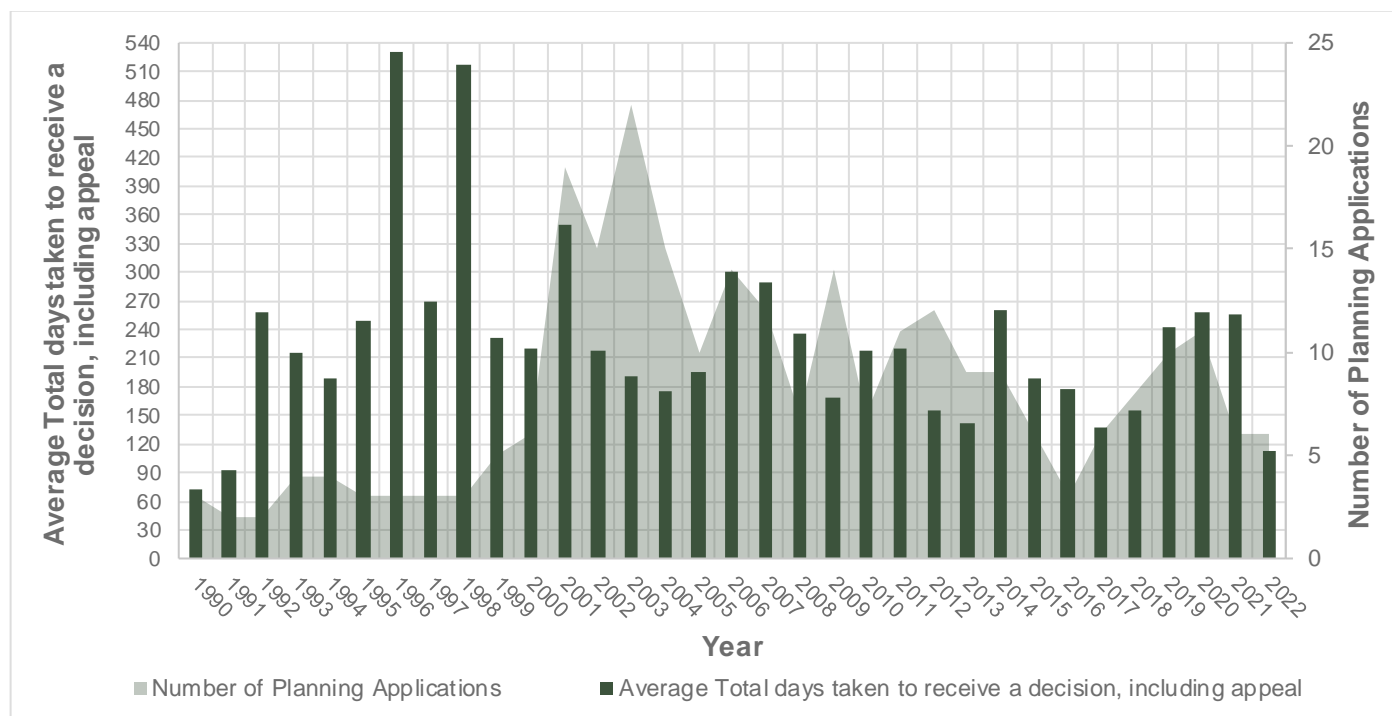
The slowest decision in this dataset is 1,162 days, relating to alterations to a composting facility near Littleton in Tipperary. As mentioned above that application and appeal remains undecided at time of writing, so the figure of 1,162 days (3 years and 2 months) is a minimum figure that is still increasing.

Figure 3-6 below presents the dataset in a different format, showing the average total time for decisions by LA & ABP for each year from 1990 to 2022 as a bar chart. The Y axis on the right hand side of the graph shows the number of applications in our dataset for each year and this is represented as an area chart behind the bar chart.

Figure 3-6 Average Total days taken to receive a decision by Year, including appeal.

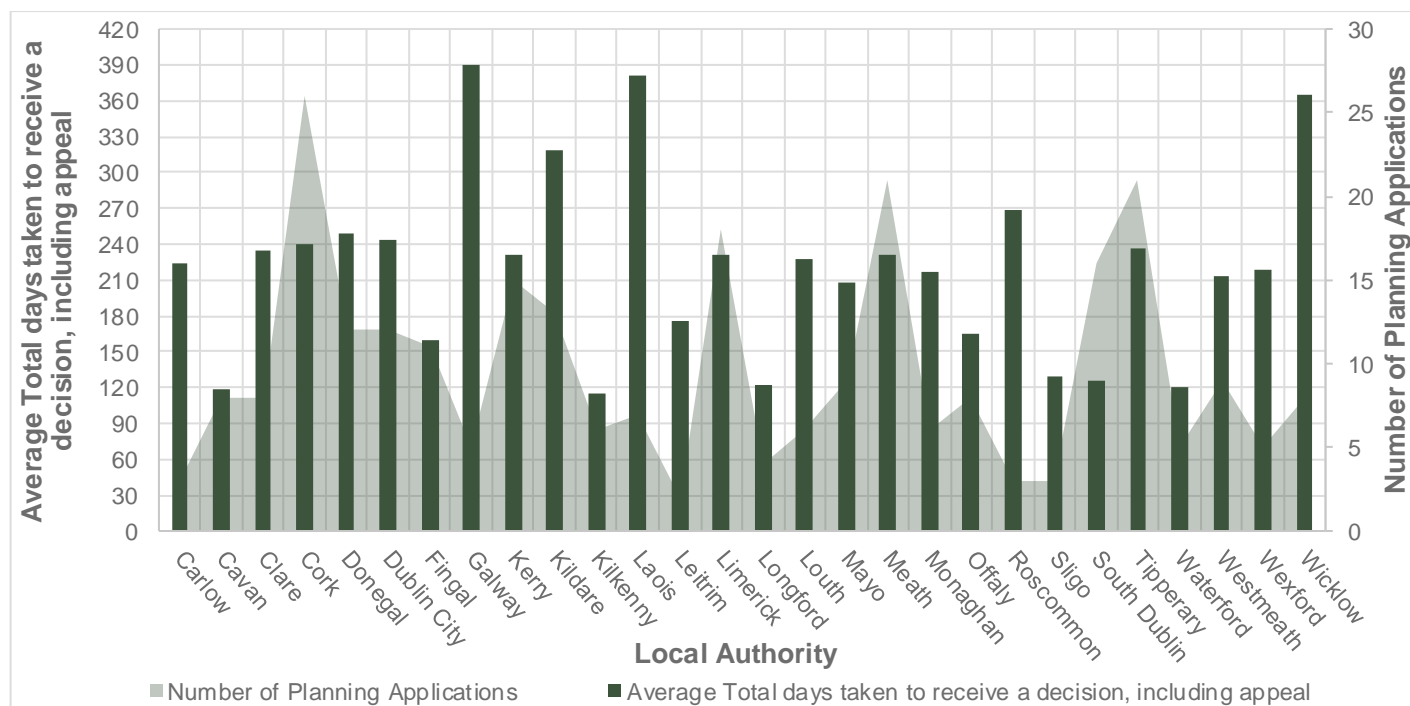


The data shows a gradual improvement in timelines over time.

- It took on average 259 days (8.5 months) to reach a decision during the 1990 to 2000 period.
- It took on average 232 days (7.6 months) to reach a decision during the 2001 to 2011 period.
- It took on average 197 days (6.5 months) to reach a decision during the 2011 to 2022 period.

Figure 3-7 shows the total average amount of days taken to receive a decision including an appeal by county during the 1990 to 2022 period.

Figure 3-7 Average Total days taken to receive a decision by County, including appeal.



The data suggests that Kilkenny had the quickest decision-making process and was found to take on average 115 days (3.8 months) to reach a decision. There were no appeals against the 6 decisions made by Kilkenny County Council in our dataset.

Counties Cavan, Waterford, Longford, South Dublin and Sligo also performed very well in the context of this dataset, with average timelines of about 4 months (118 to 129 days).

Galway had the slowest decision-making process at an average of 390 days (12.8 months). Three of the five decisions made by the Galway local authorities in our dataset were appealed by third parties. Counties Laois and Wicklow also performed very poorly in the context of this dataset, with average timelines of just over 12 months (380 and 366 days respectively). The average timelines for County Kildare were only a little shorter at 318 days.



3.2 Strategic Infrastructure Developments

Strategic Infrastructure developments are development of strategic economic or social importance to Ireland, these types of developments include those that:

- Contribute to meeting any of the objectives of the National Planning Framework, or
- Contribute significantly to meeting any regional spatial and economic strategy for an area, or
- Have a significant effect on the area of more than one planning authority ⁴.

These are not submitted to the local planning authority but instead are submitted to An Bord Pleanála for a decision.

SLR conducted an analysis on the time taken for An Bord Pleanála to reach decisions on Strategic Infrastructure Developments (SID) in the waste sector, this includes the analysis of pre-application process as well as analysis of the SID applications.

The 7th Schedule of the Planning and Development Acts contains a number of criteria that must be met for a development to come under the SID process. The threshold for waste facilities for SID is a throughput of 100,000 tonnes per annum or more. In addition to meeting that threshold, developments must meet at least one of the following three criteria:

- is of strategic economic or social importance to the State or the region in which it would be situate,
- would contribute substantially to the fulfilment of any of the objectives of the National Planning Framework or in any regional spatial and economic strategy in respect of the area or areas in which the development would be situate,
- would have a significant effect on the area of more than one planning authority.

If a waste facility development meets the 100,000 t/a throughput threshold, the process commences with a pre-application submission to An Bord Pleanála, followed by a period of consultation between the developer and the Board. The Board then decides whether the development is a SID or not. A SID application cannot be made prior to ABP making that decision, so we consider the pre-application consultation process to form part of the timeline for such planning applications. The time period between that decision being made and the application being lodged are not counted in our analysis.

Table 3-8 shows the timelines for the waste sector SID projects that are in our dataset. The year that we quote for each development relates to year of the original pre-application submission, rather than the application date.

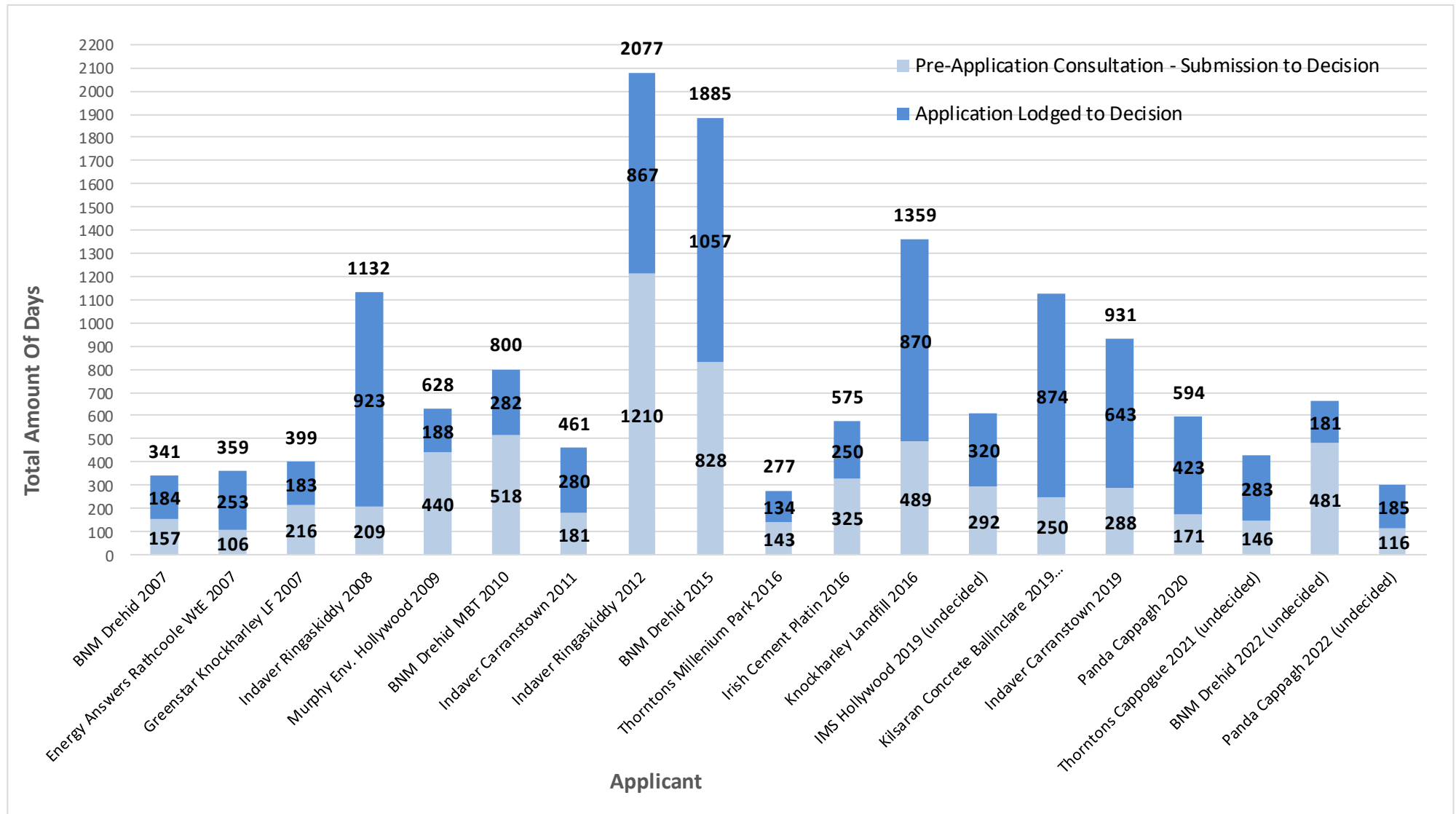
We did not include projects that have gone through the pre-application consultation process without a subsequent application being made. We also excluded applications that were withdrawn.

We have included projects where the case remains undecided at the time of writing (11th September 2023). These are identified in Table 3-8 and the total time has not been allocated to those projects, as the timeline continues to increase.

SLR found a total of 19 SIDs in the waste sector, as presented above. The average time taken for the fourteen decided cases was 844 days (2.31 years) from start to finish, including the pre-application consultation process.

The slowest SID decision in our dataset relates to Indaver's 2012 application for the development of a Waste to Energy facility at Ringaskiddy in County Cork, which took 2,077 days (5.7 years).

The Bord Na Mona Environmental Ltd. Application in 2015 took the second longest time for An Bord Pleanála to reach a decision at a total of 1,885 days (5.2 years).

The shortest timeframe was 277 days (9.1 months) for Padraig Thornton Waste Disposal Ltd in 2016 relating to the development of a Waste Transfer Station at Millenium Park in Fingal, North Dublin.
